- ✓ Fort Collins Utilities reserves the right to verify the purchase and installation location of any appliance for which a rebate is requested.
- ✓ Rebate program is subject to available funds.
- ✓ A copy of the receipt must include model number, purchase price and date of purchase.

Affidavit - Restrictions on Public Benefits

I understand that state law requires me to provide proof that I am lawfully present in the United States when asked as well as submission of a secure and verifiable document. I further acknowledge that making a false, fictitious, or fraudulent statement or representation in this sworn affidavit is punishable under the criminal laws of Colorado as perjury in the second degree under Colorado Revised Statute 18-8-503 and it shall constitute a separate criminal offense each time a public benefit is fraudulently received.
