- 💧 Visit www.ThorntonWater.com/rebates.html or call 720-977-6600 to obtain the detailed [rebate rules](#).
- 💧 The toilet rebate is valid for the replacement of **pre-1994 toilets** and is limited to the number of bathrooms in your home. The entire toilet must be replaced.
- 💧 Participants in this public program must provide proof of their lawful presence in the United States according to provisions of Colorado Law (Immigration Law, HB 06S-1023).
- 💧 Washer rebates are limited to one washing machine per household.
- 💧 Pre-owned and leased appliances do not qualify for the rebate.
- 💧 New fixture(s) may be selected for inspection by a City of Thornton representative.
- 💧 Rebate(s) will be credited to customer's utility bill or directly to applicant **if** water is paid to an HOA.

IMPORTANT TOILET REBATE STEPS:

- Step 1 - EPA WaterSense toilets must be on the approved list to qualify for the \$75 rebate.
Refer to <http://www.epa.gov/watersense/products/index.htm> for a list of approved EPA WaterSense toilets.
- Step 2 - Replace pre-1994 toilet with new toilet (save and make a copy of the itemized receipt).
Home must have been built in 1994 or earlier to qualify for the toilet rebate. No exceptions.
- Step 3 - Break the old toilet and take a picture of the old, broken toilet. A picture of each broken toilet must be attached to this rebate form. This is required to ensure the old toilet is permanently out of service. Please visit <http://www.ecocycle.org/charm> or call 303-444-6634 for toilet recycling information.
- Step 4 - Sign the Affidavit of Lawful Presence in the U.S. and **attach a copy of legal identification (ID)**.
- Step 5 - Fill out the provided form and attach copy of itemized receipt(s), photograph(s), signed affidavit, and copy of legal ID.

**IMPORTANT WASHING MACHINE REBATE STEPS:**

- Step 1 - Before you purchase, download and print out the latest Consortium for Energy Efficiency (CEE) list from <http://www.cee1.org/resid/seha/rwsh/rwsh-prod.pdf> and bring it with you when shopping for a new washing machine. The Manufacturer and Model Number of the new washing machine must be on this list to qualify for the \$100 rebate. Save and make a copy of the itemized receipt.
- Step 2 - Replace old washer with a new qualifying washer.
- Step 3 - Take a picture of the new, installed washing machine and attach it to the rebate form.
- Step 4 - Sign the Affidavit of Lawful Presence in the U.S. and **attach a copy of legal identification (ID)**.
- Step 5 - Fill out the provided form and attach copy of itemized receipt(s), photograph(s), signed affidavit, and copy of legal ID.
